Welcomed Everyone - Mayor Tony Craig; opened the floor to guests.

Stanley Walls inquired about dirt that has been disturbed by the construction of Richmond Subdivision; Mayor Craig will take care of this matter; Mr. Walls also inquired about a dirt berm being constructed and whether future owners would be able to spread that dirt; because the berm is on a U&D easement, future owners will not be permitted to alter the dirt. Mr. Walls said he recalled there were concrete ditches that were supposed to run around the perimeter of Richmond Subdivision.

Nima Naderi, Owner of Subway, addressed issues with his property flooding due to the construction of Richmond Subdivision; 14" of water was inside the store and 19" of water outside the store; extensive damage to store and equipment along with loss in sales revenue.

Jake Roth responded to Mr. Walls and Mr. Naderi explaining that he is to meet with Concord Land Developers tomorrow to address flooding issues; grass seeding and sod will assist in lessening flooding issues; Concord Land Developers are to grade out a ditch on the North side of the property to increase drainage. Mr. Roth discussed a drainage pipe that has been proposed by ALDOT to be installed in the parking

lot of Subway to drain water under the highway. OCR will not approve the final flat for Richmond to begin construction until all drainage issues are resolved.
