

RESOLUTION 23-016

DESIGNATING OFFICIAL REPRESENTATIVE FOR ADEM LOAN WASTE WATER TREATMENT PLANT

WHEREAS, the <u>Town of Owens Cross Roads</u>, herein called the "Applicant", after thorough consideration of the various aspects of the problem and study of available date, has hereby determined that the construction of certain works required for the treatment of wastewater and/or stormwater is desirable and in the public interest, and to that end it is necessary that action necessary for the construction of wastewater treatment and/or transport facilities be taken immediately; and,

WHEREAS, under Code of Alabama 1975 §§ 22-34-1 et seq., and the regulations promulgated, thereunder in ADEM Administrative Code Chapter 335-11-1, the State of Alabama, has authorized the making of loans to aid in financing the cost of construction of necessary wastewater treatment and transport works to prevent the discharge of untreated or inadequately treated effluent into any waters; and,

NOW THEREFORE, BE IT RESOLVED BY:

City Council of the Town of Owens Cross Roads

- 1. That <u>the Mayor</u> is hereby authorized to file in behalf of the Applicant an application for a loan to be made by the Alabama Water Pollution Control Authority;
- 2. That the City Clerk is hereby designated as the Authorized Representative of the Applicant for the purpose of furnishing to the Alabama Department of Environmental Management (ADEM) such information, data and documents pertaining to the application for a CWSRF loan from the Authority as may be required; and otherwise to act as Authorized Representative of the Applicant in connection with this application.
- 3. That certified copies of this resolution be included as a part of the application to be submitted to the Department for a loan.
