WHEREAS, the City recognizes the critical importance of emergency management services in ensuring the safety and well-being of its residents; and

WHEREAS, the Huntsville-Madison County Emergency Management Agency has been a valuable partner in providing essential emergency management services to the City of Owens Cross Roads; and,

WHEREAS, the City Council acknowledges the need to compensate Huntsville-Madison County Emergency Management Agency for the services available with the established partnership agreement; so,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF OWENS CROSS ROADS, AS FOLLOWS:

1. The City Council hereby approves the payment of \$4,328 to the Huntsville-Madison County Emergency Management Agency for partnership services provided to the City of Owens Cross Roads.
2. The Mayor and City Clerk are hereby authorized and directed to execute any necessary documents and to take any further actions necessary to effectuate this resolution.
3. This resolution shall take effect immediately upon its passage and approval.

As one of the municipalities covered by the Madison County Emergency Management Agency (EMA), your annual portion of the EMA budget coverage based on population is \$4,328. This amount was derived by taking the total resident population of Madison County as of December 1, 2023 and dividing it among each municipality and the unincorporated areas (the County). Owens Cross Road's population percentage was 0.71% of the total. This percentage was then applied to the total EMA budget after designated sources which was \$609,317.05.
