## RESOLUTION APPOINTING A MUNICIPAL JUDGE FOR THE MUNICIPAL COURT OF THE CITY OF OWENS CROSS ROADS

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Owens Cross Roads that Nathan Wake is hereby appointed as Municipal Court Judge for the City of Owens Cross Roads, effective December 7, 2024, and continuing through December 6, 2026.

**BE IT FURTHER RESOLVED** that the compensation for the Municipal Court Judge shall be \$750 per court for all time reasonably spent in the performance of the Judge's duties.
