### RESOLUTION APPOINTING A MUNICIPAL JUDGE FOR THE MUNICIPAL COURT OF THE CITY OF OWENS CROSS ROADS

**BE IT FURTHER RESOLVED** that the compensation for the Municipal Court Judge shall be \$750 per court for all time reasonably spent in the performance of the Judge's duties.
