RESOLUTION APPROVING A ONE-YEAR AGREEMENT WITH TANGO TANGO FOR CAD SMS SERVICES

WHEREAS, the City of Owens Cross Roads Police Department seeks to enhance its communication capabilities through the use of CAD SMS messaging services; and

WHEREAS, TANGO TANGO has been identified as a qualified provider of these services; and

WHEREAS, TANGO TANGO has submitted a quote of \$1,495 for a one-year agreement commencing on January 1, 2025, and ending on December 31, 2025;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Owens Cross Roads that the City shall enter into a one-year agreement with TANGO TANGO for the provision of CAD SMS messaging services, at a cost of \$1,495.

BE IT FURTHER RESOLVED that the Mayor, Tony Craig, or the City Clerk, Christie Eason, are authorized to sign the agreement on behalf of the City of Owens Cross Roads.
