

RESOLUTION 25-017

A RESOLUTION APPOINTING POLL WORKERS AND ESTABLISHING THEIR COMPENSATION FOR THE MUNICIPAL ELECTION IN THE CITY OF OWENS CROSS ROADS

WHEREAS, the City of Owens Cross Roads is preparing to hold a Municipal Election on August 26, 2025, with a potential run-off election on September 23, 2025; and

WHEREAS, Section 11-46-27 of the Alabama Code of 1975 and regulations adopted pursuant thereto require the municipal governing body to appoint Poll Workers not less than fifteen (15) days before the holding of any municipal election; and

WHEREAS, the City Council deems it necessary to appoint qualified individuals to serve as Poll Workers for said election; and

WHEREAS, the City Council also deems it appropriate to establish the compensation for said Poll Workers;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Owens Cross Roads, Alabama, as follows:

Section 1. Appointment of Poll Workers

The following individuals, all being qualified electors of the City of Owens Cross Roads, are hereby appointed to serve as Poll Workers for the Municipal Election to be held on August 26, 2025, and any potential run-off election to be held on September 23, 2025:

- Inspector: Jean Bearden
- Deputy Inspector: Glenda Patterson
- Poll Workers: Teresa Carter, Linda Harris, Deborah Hollingsworth, Cathy Maples, Mike Maples

Section 2. Duties of Poll Workers

The Poll Workers appointed herein shall perform all duties prescribed by law, including but not limited to:

- Conducting the election in accordance with the Alabama Municipal Election Law.
- Ensuring that all qualified electors are permitted to vote.
- Maintaining order and decorum at the polling place.
- Counting the votes and certifying the results.
- Protecting the integrity of the election process.

Section 3. Compensation of Poll Workers

The Poll Workers appointed herein shall be compensated as follows:

- Poll Workers shall receive \$225.00 for each election day served and an additional \$50.00 for attending the mandatory election training.
- The Inspector and Deputy Inspector shall each receive \$275.00 for each election day served and an additional \$50.00 for attending the mandatory election training.

Section 4. Poll Worker Training

All appointed Poll Workers are required to attend an election training session to be held on July 18, 2025.

Section 5. Authorization to Pay

The City Clerk/Treasurer is hereby authorized to draw warrants and make payments to the individuals named herein, in the amounts specified, upon completion of services rendered.

Section 6. Effective Date

This resolution shall become effective immediately upon its adoption and approval.
